2341 Minutes of the last meeting dated 17/10/07, these were approved and signed by the Chairman subject to two amendments (1) item 2339 to delete 'youngsters' (2) item 2336 to add that the second half of the annual grants are to be paid

2342 Matters arising

- 1 VMS signs have been requested, waiting on a decision. Entrance to Chapelfields, missing lamp-post sign to be replaced
- 2 Willow tree on Village Green, Councillors decided to ask again for opinions on whether it should be removed or pruned. Newsletter to give alternatives ie (1) strong pruning (2) removal and replacement with for example a 10' high slow growing oak Clerk to get quotes for pruning and removal
- 3 Telephone box/cash point on Village Green, ATM now will not happen although planning will be current for 5 years
- 4 Commuted sums, letter received from County Council Officer. Cherry Drive amenity area to be put on a future agenda. Drainage of playing field, Drainage Board report is with the Chairman and he will report at a future meeting
- 5 Parish Emergency Plan, update from Chairman. It was agreed that A Dowson, S Hamilton, R Templey and the Chairman would hold the necessary information. Chairman to arrange attendance at an emergency planning meeting in Market Weighton
- 6 'No waiting' Runner End/Selby Road, waiting for public consultation results
- 7 Market Weighton Drainage Board, flooding question, letter received was noted
- 8 Highways issues updates given Clerk to ask for resurfacing of Drain Lane to be done when capital budget allows
- 9 Street Lighting, approximate cost to bring Parish Council owned lights up to maintenance standard is £4000, East Riding Council will survey to calculate how many more will be needed to bring up to adoption standards
- 10 Election costs, letter received from Beverley was discussed and deemed inadequate. Clerk to write to ask for full information and then to pay half of the bill and the remainder when the next precept received, proposed C Worrall seconded A Payne approved unanimously
- 11 Litter bins siting, Chairman updated the meeting and will arrange with S Hamilton. Clerk to confirm Back lane siting with Beverley
- 12 Electoral Roll now received from Beverley
- 13 Surgery car parking problems, surgery reply was noted. Clerk to ask if the shrubs could be removed to allow extra parking
- 14 Parish Council meetings public session, it was decided unanimously to hold the public session at the start of each meeting and Parish Council standing orders will be changed to allow this. The 5 day notification to the Clerk will remain

Planning appeal has been dismissed upholding East Riding's original decision for Woodlands Farm, Cliffe Lane, GR & JM Shaw, erection of dwelling in connection with agriculture
Other planning issues

1. Concerns reported that a chicken unit is being built on Baileywood Lane without permission
2. Concerns reported that a unit on Sands Lane Nurseries is being used commercially to build exhibition units without permission
3. Concerns reported that a caravan on Drain Lane is being lived in without permission

Clerk to ask for these concerns to be investigated

Support in commenting on Planning Applications, the East Riding training module was noted

Insurance, auditors recommendation to extend fidelity cover to Councillors as well as the Clerk, this has been included on the policy at nil cost this year

Village Hall grant application, letter received from secretary was considered. W Evans left the meeting during discussion on this item

Proposed S Appleyard seconded E Smith that £1200 be awarded, Amendment proposed S Hamilton seconded A Payne that £1150 be awarded. Voting on the amendment was 4 for 2 against with 2 abstentions. This therefore became the proposal and was passed by 4 votes to nil with 4 abstentions

Precept proposals

1. Grants, that a reserve of 20% be included in the precept, approved unanimously
2. Proposed E Smith seconded S Hamilton that £1100 be included for the provision of ground-works to allow a Christmas tree on The Green, approved unanimously
3. Proposed C Worrall seconded S Hamilton that £500 be included for Christmas tree lights, approved unanimously
4. Proposed W Evans seconded R Templey that £4000 be included for upgrading of street lights, approved unanimously

Precept sum : proposed C Worrall seconded S Hamilton that this be set at £25,000, approved unanimously
